In pursuance to Directorate of Skill Development Department J&K, Jammu Admission Notice under endorsement No: DSD/401/Trgs/2024/4785-4875 Dated: 28-05-2024, Online applications are thus invited from desirous candidates for seeking admission in Govt. ITI Bhaddu/Billawar for the academic session 2024-25-26 in various Engineering/Non-Engineering Trades having duration of Two years/One year for free & Self- finance seats being run under NCVT/SCVT Schemes and commencing from 2<sup>nd</sup> of September 2024 for which the forms can be uploaded from 01st of June 2024.

The desirous candidates having minimum age of 14 years as on 1<sup>st</sup> June 2024 with no upper age bar have to fill up the admission forms online available at ITI admission portal viz (<a href="http://itiadmissions.jkdsd.in">http://itiadmissions.jkdsd.in</a>) link is also present on the official website of Directorate of Skill Development J&K i.e. <a href="https://www.jkdsd.org">www.jkdsd.org</a>.

The last date for applying online is up to 21st of June 2024. The candidates have to fill up the complete details like name, parentage, qualification etc. online in the portal and have to upload the following documents on the portal:

- 1. Marks Certificate of Qualifying examination
- 2. Date of birth Certificate.
- Category Certificate (SC/ST/Ex-serviceman/ EWS /Physically Handicapped) if any
- 4. Aadhaar card
- 5. Domicile certificate should be produced at the time of admission in ITI

The candidates after finalizing the profile and application online will be required to deposit the print out of the system generated application in the concerned ITI in which the candidate is applying along with self attested photo copies of above mentioned required documents in the respective Institutes, the Candidate has to pay a fee of Rs.100/- (One hundred only) per three trades in which he/she is seeking admission against cash receipt form Govt. ITI Bhaddu/Billawar.

#### IMPORTANT NOTE:

- The applying candidate has to submit printout of system generated application along with requisite self-attested documents at Govt. ITI Bhaddu/Billawar.
- The candidate shall deposit the fee @ 100/- (One hundred only) per three trades at Govt. ITI Bhaddu/Billawar against a proper receipt.
- Selection will be made purely on the basis of academic Merit obtained by the applicant in their qualifying examination prescribed for each trade (both for Free & Self finance Seats separately)
- On successful completion of training in trades running under NCVT/SCVT Scheme, Certificates will be awarded by the National /State Council for Vocational Training.
- Candidates, who have already undergone training in any of the trades of ITIs, can apply for admission in another trade after two years of completion of previous training course. However, for the ensuing academic session their admission can be considered in any of the trades having poor response.
